Ms. Farber introduced Michael Engle, Senior Director of Ambulatory Care Services and Russell Nord, MD, Medical Director, Sports Medicine Program who discussed the Washington Sports Medicine program. Mr. Engle discussed the history of the Sports Medicine Program and reviewed services currently provided including pre-participation physicals, support from certified athletic trainers and coordination of the program with the Washington healthcare system.

OTHER UPDATES

Ed Fayen, Senior Administrative Associate presented a construction update. Mr. Fayen noted we are getting close to going to bid. We are close to awarding the demolition permit, which will be brought forward at a future Board meeting. Mr. Fayen reported the garage is currently in the permit review stage and also starting to go before the planning commission of the City of Fremont for an architectural review. Mr. Fayen shared the conditions regarding the permits noting the comments received from the Construction Permit Review appeared to be a combination of the Planning Commission viewpoint and from the Permit viewpoint; we are in the process of responding.

Barbara Eusebio. Chief of Ouality and Resource Management presented the Hospital Outpatient Quality Reporting Program, Calendar Year 2014.

Ms. Eusebio noted the Centers of Medicare and Medicaid Services (CMS) requires hospitals to report outpatient data for services to receive the full annual payments. A 2% reduction is applied to annual payment for hospitals not meeting requirements. The Outpatient program is actively modeled on the current quality data reporting program for inpatient services. The purpose of this includes emphasis on reducing unnecessary diagnostic/therapeutic care, promotion of efficient and high quality patient care, maintaining transparency of data among the members of the community, ensuring resources are neither under nor over utilized, and allowing for benchmarking and best practices. The next steps will include ongoing monitoring of performance over time, evaluating necessity of identified tests and follow-up procedures, and education efforts on appropriateness of tests and risks/benefits involved.

Chris Henry, Chief Financial Officer, presented the Finance Report for December 2013. The average daily census was 167.1 with admissions of 1,010 resulting in 5,181 patient days. Outpatient observation equivalent days were 248. The average length of stay was 4.83 days. The case mix index was 1.458. Deliveries were 136. Surgical cases were 340. Joint Replacement cases were 110. Neurosurgical cases were 9. Cardiac Surgical cases were 9, and the Outpatient visits were 7,101 and Emergency visits were 4,243. Total productive FTEs were 1,225.6. FTEs per adjusted occupied bed were 6.53.

Ms. Farber presented the Hospital Operations Report for January. There were 1,036 admissions with an average daily census of 178. This was lower than the budget of 1,106 admissions and 9.7% below the budgeted average daily census of 197. Preliminary information indicated inpatient revenue for the month of January at approximately \$138,800,000; 62.2% was Medicare and 14.2% was Medi-Cal, for a total of 76.4% in government program revenue. There were 40 deliveries in the Hospital. There were 366 surgical cases at the Hospital and 613 cases at the Outpatient Surgery Center. The Emergency Room saw 4,709 patients. The clinics saw approximately 4,731 patients. FTEs per Adjusted Occupied Bed were 6.23.
