**SUBJECT:** New Board Resolution to Replace Board Resolution #1071 - LAIF

#### **Board Resolution Summary:**

The original Board Resolution#1071, dated 2008, authorizes the Chief Executive Officer, the Chief Financial Officer, and the Associate Administrator of the District to deposit and withdraw funds in the Local Agency Investment Fund (LAIF) in the State Treasury.

Since then titles have changed and in order for Ed Fayen, Executive Vice President, to continue to be an authorized signer on the LAIF account an updated Board Resolution is required. The trustee of the bond proceeds has also changed from Union Bank of California, N.A. to U.S. Bank.

The new Board Resolution is updated to 1) include the Executive Vice President position and 2) omit the name of the trustee bank, so that the there is no need for a new resolution in the event that the trustee changes in the future.

The attached Board Resolution is to be signed by Chris Henry, Edward Fayen, Kimberly Hartz, and members of the Board.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Washington Township Health Care District does hereby authorize the deposit and withdrawal of monies in the Local Agency Investment Fund in the State Treasury in accordance with the provisions of Section 16429.1 of the Government Code for the purpose of investment as stated therein, and verification by the State Treasurer's Office of all banking information provided in that regard.

WHEREAS, the Board has determined that the State of California created the Local Agency Investment Fund pursuant to Chapter 730 of the statutes of 1976 Section 16429.1 of the California Government Code for the deposit of money of a local agency for investment by the Statement Treasurer, and

WHEREAS, the Local Agency Investment Fund meets the requirements of the District's deposit and withdrawal needs for purposes of investing operating fund monies and bond proceeds.

WHEREAS, Union Bank of California, N.A. is the Trustee and fiscal agent for the Washington Township Health Care District, General Obligation Bonds, 2004 Election, 2006 Series A and the Refunding and Revenue Bonds, 2007 Series A.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Washington Township Health Care District does hereby authorize the deposit and withdrawal of monies in the Local Agency Investment Fund in the State Treasury in accordance with the provisions of Section 16429.1 of the Government Code for the purpose of investment as stated therein, and verification by the State Treasurer's Office of all banking information provided in that regard.
