He added the report will be available through the WHHS website and copies would also be available at the Community Relations Department, 2500 Mowry Ave., Fremont, CA 94587.

It was also noted that the Annual Reports will be scheduled following the Hospital's fiscal year schedule, July-June. Mr. Marks indicated the Annual Report (for period ending June 30, 2007) will be presented to the Washington Township Board of Directors by April 2008.
